(hereinafter referred to as IEC) who shall have full power to interpret and to make or amend these rules, provided that such amendments and additions do not operate to diminish the rights reserved for the Exhibitor/ Registrant under this contract/application, and shall not operate to increase liabilities of its Sponsors, Agents or Employees.

B/ No exhibitor shall be permitted to exhibit unless he has paid prior to the exhibition all of the fees agreed to on the reverse side.

C/ Exhibitors are expected to comply with any building regulations and all Government rules and regulations.
